

Terms and Conditions for Bandhan Bank Elite Plus Debit Card offer on BookMyShow

'Offer' details:

- Buy 1 movie ticket and get 1 free movie ticket up to ₹750 with Bandhan Bank Elite Plus Debit Card.
- The 'Offer' can be availed for booking of movie tickets on BookMyShow app/website.
- Offer Period: 'Offer' applicable from November 15, 2024 to November 14, 2025 ('Offer Period').
- 'Offer' valid twice per card per month during the 'offer' duration on movie tickets.
- Maximum monthly discount for movie ticket is capped at ₹750.
- Minimum 1 ticket to be booked in order to avail the 'offer'.
- 'Offer' valid on all days of the week.
- 'Offer' is valid on movies only excluding events, concerts, plays, sports and activities, BookMyShow Stream and F&B.

Steps to avail the 'offer':

- Go through the regular ticketing flow of BookMyShow app/website for selecting the movie of your choice.
- Proceed to the payments page.
- Confirm your details by providing your email id & mobile number that is registered on the app.

- Choose "Bandhan Bank Elite Plus Debit Card 'Offer' from the list.
- Enter your 16-digit Bandhan Bank Elite Plus Debit Card number in the box and click on "Check/Apply 'Offer'.

- To make the remaining payment, proceed to secure payment page, enter expiry, CVV card details and name on the card.
