



Terms & Conditions for “Milestone Voucher Bundle” for Bandhan Bank Elite Plus Debit Card

- Bandhan Bank Elite Plus Debit Card (“**Cardholders**”) are entitled to receive Milestone Voucher Bundle (“**Voucher Bundle**”) on achieving annual milestone spends of ₹8 lakh in a card membership year (“**card membership year**” means the year beginning with the debit card issue date)
- Voucher Bundle issuance is subject to net cumulative spend transactions on eligible categories done on the card during the card membership year
- Milestone Voucher Bundle will only be earned on eligible PoS/e-com spend transactions. Eligible spends transactions are defined as eligible spends excluding reversals, cancellations, refund, fraud transactions, cash withdrawals, fee & other charges, and certain MCCs (Merchant Category Codes) as follows:
